Level 3 Sex Offender - Detail Flyer

Information shall **NOT** be used to commit a crime or to engage in illegal discrimination or harassments of an offender. Any person who uses information disclosed pursuant to **M.G.L. C. 6 §§ 178C - 178Q** for such purposes shall be punished by not more than two and one half (2 ½) years in a house of correction or by a fine of not more than one thousand dollars (\$1000.00) or both (**M.G.L. C.6, § 178N**). In addition, any person who uses Registry information to threaten to commit a crime may be punished by a fine of not more than one hundred dollars (\$100.00) or by imprisonment for not more than six (6) months (**M.G.L. C. 275 § 4**).
